Endress+Hauser Canada's Commitment to You

In our customer interactions:

- We will ask you first if you are prepared and ok with an in-person visit.
- We will review and comply with your precautions and safety measures while on your site.
- We will take our temperature every morning. If above 37.8 °C, we will cancel the in-person meeting and change it to a digital platform.
- We will use hand sanitizer before entering any building, and upon leaving any building.
- We will suspend the exchange of business cards and will share our contact information via AirDrop, text or email.
- We will adhere to no handshaking or touching.
- We will maintain physical distance protocols of more than 2 metres or 6 feet apart.
- We will wear a mask, covering both mouth and nose.
- We request that our customers and distributors also wear a mask or face shield, and we will discuss this requirement before the meeting to gain mutual commitment. If this request is not possible, we will change the meeting to a digital platform.
- We will obey provincial and federal guidelines regarding the maximum number of people allowed in attendance.
- All samples will ship directly to the customer to minimize the touchpoints before receipt.

In our logistics operations:

- All employees will take their temperature daily and will call in sick if elevated.
- All employees will wear masks.
- Reduced amount of in-office workers through work from home protocol to achieve
 2 metres or 6 feet worker separation.
- Modified procedures for warehouse staff to reduce interaction with delivery drivers.
- All incoming shipments are quarantined prior to shipping to customer.
- Distribution areas are off limits to all non-warehouse personnel.
